ORDER OF MANDATORY PERMANENT INJUNCTION

JUDGMENT AND ENFORCEMENT

This matter coming on to be heard on the regular trial call and on motion of plaintiff, CITY OF CHICAGO, and this Court having jurisdiction over the parties and being fully advised in the premises, and having heard evidence and testimony that the following items in the City's complaint are not complied to date, to wit:

The City's complaint in its entirety

IT IS HEREBY ORDERED THAT:

1. The judgment(s) hereby entered on the date(s) of SEPTEMBER 25, 1998 in the total amount(s) of \$ 12,200.00 plus \$60.00 in court costs against defendant(s) KWOK CHEUNG; ILENE CHEUNG shall stand as final judgment(s) and that leave for enforcement on said judgment(s) is granted Plaintiff, CITY OF CHICAGO, instanter, and ILENE CHEUNG IS IN DEFAULT FOR FAILURE TO APPEAR

2. There is a mandatory permanent injunction against defendant(s) ILENE CHEUNG ET AL his/her/their agents, heirs, successors or assigns, against the rent, use, lease or occupancy of subject premises until full compliance with the codes of the City of Chicago

4. The defendants shall fully comply with the codes of the City of Chicago by 11/25/98
3. The court reserves jurisdiction of this matter for the purposes of modification, enforcement or termination of this permanent injunction.

IT IS FURTHER ORDERED that this cause is hereby dismissed subject to the above mandatory permanent injunction, and, the above lien and personal judgment(s) against the named defendant(s) in the aforesaid amount(s).

This order is final and appealable, the court finding no just cause for delay in its enforcement or appeal.
