IT IS HEREBY ORDERED THAT:

1. The judgment(s) hereby entered on the date(s) of 28 SEPTEMBER 98 in the total amount(s) of \$ 5,600.00 plus \$60.00 in court costs against defendant(s) SYLVIA BAHENA shall stand as final judgment(s) and that leave for enforcement on said judgment(s) is granted Plaintiff, CITY OF CHICAGO, instanter.

2. There is a mandatory permanent injunction against defendant(s) JESUS BAHENA et al SYLVIA BAHENA his/her/their agents, heirs, successors or assigns, to stop work on subject premises until zoning approval permits are obtained

3. The court reserves jurisdiction of this matter for the purposes of modification, enforcement or termination of this permanent injunction.

IT IS FURTHER ORDERED that this cause is hereby dismissed subject to the above mandatory permanent injunction, and, the above lien and personal judgment(s) against the named defendant(s) in the aforesaid amount(s).
