- 4. The Subconnact was entered into between MTI and Kendall with the full knowledge and consent of the Owner. Alternatively, the Owner specifically authorized MTI to enter into contracts for and in said improvement of the Real Estate.

As of the date hereof, there is due, unpaid and owing to Claimant, after allowing credits for payments by Kendall, the balance of One Thousand, Six-Hundred and Twenty-Seven Dollars & 03/100, (\$1,627.03), for which with interest, Claimant claims a lien on the Real Estate and on the monies or other considerations due or to become due from Owner to Kendall Electric.
