LEASE SUBORDINATION AGREEMENT

THIS LEASE SUBORDINATION AGREEMENT (this "Agreement"), dated this 29+6 day of October, 1998, between NETCOM, INC., an Illinois corporation ("Tenant"), and NATIONSCREDIT COMMERCIAL CORPORATION (in its individual capacity, "NationsCredit"). having an office at 187 Danbury Road, Wilton, Connecticut 06897, as agent (NationsCredit in its capacity as agent being hereinafter refer ed to as "Agent") for Lenders (as "Lenders" is defined in the Credit Agreement referred to below).

RECUTALS

- Tenant is the lessee under that certain Incustrial Building Lease executed between Tenant and Netcom Properties Inc., an Illinois corporation ("Landlord"), dated January 1, 1998 (the lease and all amendments thereto are hereinafter referred to as the "Lease"), covering all of the property located at 599 South Wheeling Road, Wheeling, Illinois, 50090 and legally described in Schedule I attached hereto and made a part hereof (the "Property").
