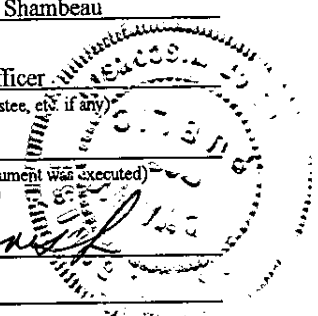



LEGAL DESCRIPTION


