ORIGINAL CONTRACTOR'S CLAIM FOR LIEN

That on February 14, 1997, the claimant made a contract with 5350 South Shore, L.L.C., who was authorized or knowingly permitted by TRUSTEE to make said contract for the furnishing of concrete materials and labor for the townhouse development being erected on said land for the sum of Four Hundred Forty-Four Thousand Dollars (\$444,000.00) and on July 13, 1998, completed thereunder all required by said contract to be done.

That at the special instance and request of said owners, the claimant furnished extra and additional materials and extra and additional labor for said premises to the value of Forty-Two Thousand Six Hundred Fifty Dollars (\$42,650.00) and completed same on July 13, 1998.
