Borrower shall not destroy, damage or impair the Property, allow the Property to deteriorate, or commit waste on the Property. If the Property is abandoned by Borrower, or if, after notice by Lender to Borrower that the consemnor offers to make an award or settle a claim for damages. Borrower fails to respond to Lender within 30 days after the date to proceed is given, Lender is authorized to collect and apply the proceeds, at its option, either to restoration or repair of the Property or to the sums secured by this Security Instrument, whether or not then due.

Unless Lender and Borrower otherwise agree in writing, any application of proceeds to principal shall not extend or postpone the due date of the monthly payments referred to in paragraphs 1 and 2 or change the amount of such payments.

- 11. Borrower Not Released; Forbearance By Lender Not a Waiver. Extension of the time for payment or modification of amortization of the sums secured by this Security Instrument granted by Lender to any successor in interest of Borrower shall not operate to release the liability of the original Borrower or Borrower's successors in interest. 17. Borrower's covenants and agreements shall be joint and several.
