Parcel 2

Easement for the benefit of Parcel 1 for ingress, egress, support, use and enjoyment of the property as set forth in the Manhattan Building Declaration of Covenants, Conditions, Restrictions and Easements recorded as Document 97-579282.



This Deed is made subject to the lien of every Trust Deed or Mortgage (if any) of record in said county affecting the real estate or any part thereof given to secure the payment of money and remaining unreleased at the date of delivery hereof.


