That on December 09, 1997, the claimant made a contract with said owner for installation of 13 storm windows and white alluminium cupping, all for the building erected on the land for the sum of \$6,748.00 and the owner didn't cancell the contract within three bussiness days allowed by law. That, pursuant to contract, said owner is obligated to pay a 10% cancellation fee if cancellation occurs before work is begun, leaving due to claimant the balance of SIX HUNDRED SEVENTY FOUR DOLLARS AND 80/100 (674.80) DOLLARS, plus \$100.00 costs, which, with interest, the claimant claims a lien on said land.

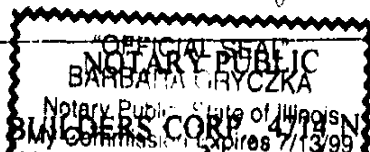
