KNOW ALL MEN BY THESE PRESENTS,

LEE, HIS WIFE, its heirs, legal representatives and assigns all the right, title, interest, claim, or demand whatsoever I may have acquired in, through, or by a certain MORTGAGE bearing date the 13TH day of NOVEMBER, 1990 DOCUMENT NO. 90605139 recorded in the Recorder's Office of COOK County, in the State of ILLINOIS to the premises therein described as follows, to wit:

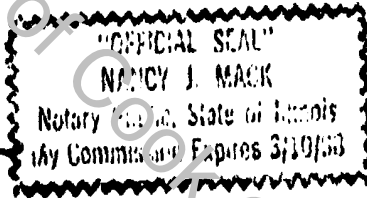
