SUBORDINATION AGREEMENT

THIS INDENTURE made this 7 day of November, 1997. 3

WHEREAS, FIRST OF AMERICA BANK-ILLINOIS, N.A., a corporation, with principal offices located in Bannockburn, Illinois, has heretofore made a loan secured by a mortgage on the hereinafter described real estate located in Cook County, Illinois, which first mortgage was made by Rita J. Miller, as a single person, said mortgage being dated August 5, 1994, and recorded in the Office of the Cook County Recorder of Deeds on August 31, 1994, as Document No. 94 768 435 said mortgage encumbering the following described property:

LOT SEVENTEEN (17) IN LOCASCIO'S SUBDIVISION UNIT 2, BEING A RESUBDIVISION OF PART OF THE NORTHEAST QUARTER (1/4) OF SECTION 20, TOWNSHIP 42 NORTH, RANGE 11, EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO PLAT THEREOF REGISTERED IN THE OFFICE OF THE REGISTRAR OF TITLES OF COOK COUNTY, ILLINOIS, ON MAY 22, 1969, AS DOCUMENT NUMBER 24 52 329.

AND WHEREAS, FIRST OF AMERICA MORTGAGE COMPANY proposes to make a further mortgage loan to Rita J. Miller, as a single person, in the amount of \$91,000.00, which mortgage lien shall be evidenced by a certain promissory note and secured by a mortgage upon the same above-described property in Cook County, Illinois.

NOW, THEREFORE, FIRST OF AMERICA BANK-ILLINOIS, N.A. does hereby subordinate the lien of the mortgage dated August 5, 1994 to the proposed mortgage lien described above. All other terms and conditions of both liens shall remain in full force and effect, this Agreement being solely for the purpose of subordinating the lien of the first described mortgage to that of the second described mortgage.
