Com Products agrees to perform and be bound by all of the covenants, agreements, obligations, terms, provisions and conditions on the next of CPC set forth in the Agreement.

This Notice of Assignment shall not affect any obligations or liabilities of CPC under the Agreement that arise or relate to events occurring on or before the assignment of the Agreement from CPC to Com Products. EXHIBIT A

LEGAL DESCRIPTION

"That part of Sections fourteen (14) and twenty-three (23), Township thirty-eight (38) North, Range twelve (12), East of the Third Principal Meridian, bounded as follows: beginning at the point of intersection of the Northerly Reserve Line of the Illinois and Michigan Canal, with the North line of said Section twenty-three (23) running thence Southwest on said Northerly Reserve Line of the Illinois and Michigan Canal, to its intersection with a line twelve hundred (1200) feet South of and parallel with said North line of Section twenty-three (23) running thence Northwest and at right angles with said Northy Reserve Line to the South dock line of the Main Channel of the Sanitary District of Chicago, said South dock line being one hundred twenty (120) feet distant from (raeasured at right angles in a Southerly direction) the center line of said Main Channel running thence Northeast along said South dock line to a point opposite the point of beginning, running thence Southeast and at right angels to said South dock line to the point of beginning, containing fourteen and two one-hundredths (14.02) acres, more or less, situated in the County of Cook and State of Illinois."
