CLAIM FOR LIEN

The undersigned claimant, Sound Sales, Ltd., of 38 N. Broadway, Des Plaines, Illinois, (hereinafter referred to as "Lien Claiman"), makes the following statement and claims a mechanic's lier under the Mechanics' Lien Act of the State of Illinois, as set forth in 770 ILCS 60/1 et seq. On or about May 1997, the Subcontractor entered into a subcontract with Lien Claimant to supply fabric covered acoustical wall panels for the building and improvements on the Premises, in the amount of \$48,838.00.
- 4. On or about October 28, 1997 Lien Claimant substantially completed delivery of materials to the value of \$48,838.00 under its subcontract with Subcontractor.
- 5. There is now due Lien Claimant, after allowing to the Owner or Owner's Tenant all credits, deductions, and set-offs, the amount of \$25,485.00, including extras.
- 6. The claimant now claims a lien on the premises and all improvements on it, against all persons interested, and also claims a lien on any amounts due from the Owner, or Owner's

Tenant to Original Contractor, for \$25,485.00, with interest, according to the statute.
