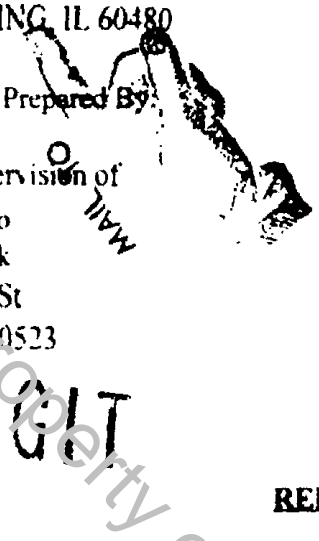

RELEASE DEED
