#### IOFFICIAL C THE COVENANTS, CONDITIONS AND PROV 1. Promises of Romower - Bonower represents and warrants that:

a. Borrower owns the Property.

b. Romower has the right to mortgage, grant, and convey the Property to Trustee; and

c. There are no claims or charges outstanding against the Property except any mortgages or trust deeds that are currently shown in the office where real estate records are filed for the County where the Property is located.

Borrower gives a general warranty of title to Trustee on behalf of the Holder of the Note.
