

19. RIGHT OF REPURCHASE.

- Purchaser hereby represents and warrants as of the date hereof and as of the Closure Date that the deserts (a) acquiring the Dwelling Unit for personal use and not for resale or lease and that in acquiring the Dwelling Unit, Purchaser is not acting as agent or nominee for any undisclosed party. Purchaser hereby grants Seller a right to repurchase the Dwelling Unit on the terms and conditions hereinafter set forth.
