4. Charges; Liens. Borrower shall pay all taxes, assessments, charges, fines and impositions attributable to the Property which may attain priority over this Security Instrument, and leasehold payments or ground rents, if any. 7. Protection of Lender's Rights in the Property. - 12. Successors and Assigns Bound; Joint and Severable Liability; Co-signers.
