- (14) Complete check-up and overhaul of both heating systems (for first and second floors).
- (15) Venting of jacuzzi and bedroom areas: exhaust fars had been installed by others; Mr. Kupferberg asked GEORGE GINIS to complete the job; the openings of the exhaust fans, 4" in diameter, were 2" from the rafters, so besides the venting work, structural work also had to be done to support the rafters.
