### REVOLVING JUNIOR MORTGAGE, SECURITY AGREEMENT AND ASSIGNMENT OF LEASES AND RENTALS (WITH TRUSTEE)

THIS REVOLVING JUNIOR MORTGAGE, SECURITY AGREEMENT AND ASSIGNMENT OF LEASES AND RENTALS's made this 3rd day of December, 1997 by American National Bank and Trust Company of Chicago, not personally but as Trustee under a Trust Agreement dated August 21, 1991, and known as Trust No. RV-011352 (the "Mortgagor"), and Michael J. Kerpel (the "Beneficiary"), to THE FIRST NATIONAL BANK OF CHICAGO, (the "Mortgagee"), a national banking association, organized and existing under the laws of the United States of America, having its principal office at One First National Plaza, Chicago, Illinois 60670.

In the exercise of the powers herein granted Mortgagee, no liability shall be asserted or enforced against Mortgagee, all such liability being expressly waived and released by Mortgagor and Beneficiary.

#### ARTICLE VIII DEFAULT

- 8.01 The occurrence of any one or more of the following events shall constitute an event of default (each, an "Event of Default") under this Mortgage:
  - (a) Failure of Mortgagor or Beneficiary to observe or perform any of the covenaris or conditions by Mortgagor or Beneficiary to be performed under the terms hereof.
  - (b) Nonpayment of principal under the Note when due, or nonpayment of interest under the Note or of any other obligations under any of the Loan Documents within five days after the same becomes due.
