EXHIBIT 'A'

Legal Description:

PARCEL 1: THAT PART OF LOT 1 IN RUFFLED FEATHERS GOLF CLUB COMMUNITY, BEING A RESUBDIVISION OF LOTS 118 THRU 144 IN RUFFLED FEATHERS, BEING A SUBDIVISION OF PART OF SECTION 27 AND PART OF THE NORTH 1/2 OF SECTION 34, ALL IN TOWNSHIP 37 NORTH, RANGE 11, EAST OF THE THIRD PRINCIPAL MERIDIAN, DESCRIBED AS FOLLOWS: BEGINNING AT THE SOUTHEAST CORNER OF AFOREMENTIONED LOT 1; THENCE SOUTH 78 DEGREES 10 MINUTES 55 SECONDS WEST ALONG THE SOUTH LINE OF SAID LOT 1, 102.63 FEET TO THE SOUTHWEST CORNER THEREOF, SAID POINT ALSO BEING IN THE NORTHEAST RIGHT-OF-WAY LINE OF THE INTERSECTION OF PINE NEEDLES DRIVE AND LONG COVE DRIVE; THENCE NORTHWEST ALONG THE ARC OF A CURVE BEING CONCAVE TO THE NORTHEAST AND HAVING A RADIUS OF 119.00 FEET, FOR AN ARC LENGTH OF 88.75 FEET; THENCE NORTH 79 DEGREES 42 MINUTES 20 SECONDS EAST, 139.98 FEET; THENCE SOUTH 11 DEGREES 29 MINUTES 16 SECONDS EAST ALONG THE EAST LINE OF SAID LOT 1, 75.10 FEET TO THE POINT OF BEGINNING, ALL IN COOK COUNTY, ILLINOIS.

PARCEL 2: EASEMENTS FOR INGRESS AND EGRESS FOR THE BENEFIT OF PARCEL 1 OVER OUTLOTS P AND R AS CREATED BY RUFFLED FEATHERS PLAN OF SUBDIVISION AFORESAID.

PARCEL 3: EASEMENTS FOR INGRESS AND EGRESS FOR THE BENEFIT OF PARCEL 1 OVER OUTLOTS 23, 24 AND 25 IN RUFFLED FEATHERS GOLF CLUB COMMUNITY AFORESAID.
