

NOW, THEREFORE, the Declaration is hereby amended as follows:

- 1. The Declaration is hereby amended to designate as Parcels a portion of the Property, as legally described in Schedule A attached hereto, pursuant to the terms of the Declaration.
- 2. Exhibit E attached to the Declaration is hereby deleted and Exhibit E attached hereto is hereby substituted therefore.
- 3. Except as expressly amended hereby, the Declaration shall remain in full force and effect in accordance with its terms. The Second Amendment shall be effective from and after the recording of this document with the Recorder of Deeds of Cook County, Illinois.
