### Legal Description:

PARCEL 1: THAT PART OF LOT 1 IN RUFFLED FEATHERS GOLF CLUB COMMUNITY, BEING A RESUBDIVISION OF LOTS 118 THRU 144 IN RUFFLED FEATHERS, BEING A SUBDIVISION OF PART OF SECTION 27 AND PART OF THE NORTH 1/2 OF SECTION 34, ALL IN TOWNSHIP 37 NORTH, RANGE 11, EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT THEREOF RECORDED NOVEMBER 15, 1996 AS DOCUMENT NUMBER 96873927 DESCRIBED AS FOLLOWS: COMMENCING AND BEGINNING AT THE SOUTHEAST CORNER OF AFOREMENTIONED LOT 1; THENCE SOUTH 78 DEGREES 18 MINUTES 55 SECONDS WEST ALONG THE SOUTH LINE OF SAID LOT 1, 102.63 FEET TO THE SOUTHWEST CORNER THEREOF, SAID POINT ALSO BEING IN THE NORTHEAST RIGHT-OF-WAY LINE OF THE INTERSECTION OF PINE NEEDLES DRIVE AND LONG COVE DRIVE; THENCE NORTHWEST ALONG THE ARC OF A CURVE BEING CONCAVE TO THE NORTHEAST AND HAVING A RADIUS OF 113.00 FEET, FOR AN ARC LENGTH OF 58.17 FEET; THENCE NORTH 79 DEGREES 42 MINUTES 28 SECONDS EAST, 133.90 FEET; THENCE SOUTH 11 DEGREES 29 MINUTES 16 SECONDS EAST ALONG THE EAST LINE OF SAID LOT 1, 45.24 FEET TO THE POINT OF BEGINNING, ALL IN COOK COUNTY, ILLINOIS.
