NON-UNIFORM COVENANTS. Borrower and Lender further covenant and agree as follows:

**17. Assignment of Rents.** Borrower unconditionally assigns and transfers to Lender all the rents and revenues of the Property. Borrower authorizes Lender or Lender's agents to collect the rents and revenues and hereby directs each tenant of the Property to pay the rents to Lender or Lender's agents. However, prior to Lender's notice to Borrower of Borrower's breach of any covenant or agreement in the Security Instrument, Borrower shall collect and receive all rents and revenues of the Property as trustee for the benefit of Lender and Borrower. 

A new interest rate calculated in accordance with paragraphs (C) and (D) of this Rider will be published, (v) the new monthly payment amount, (vi) the Change Date, (vii) the old interest rate, (viii) the new and must set forth (i) the date of the notice, (ii) the Change Date, (iii) the old interest rate, (iv) the new amount. The notice must be given at least 25 days before the new monthly payment amount is due, Lender will give notice to Borrower of any change in the interest rate and monthly payment and interest.

## (G) Effective Date of Changes

The result of this calculation will be the amount of the new monthly payment of principal published, (vii) the method of calculating the change in monthly payment, and (viii) any other information which may be required by law from time to time.
