WHEREAS, Thirty - Three Three Hundred and Twenty - Nine and 00/109 Collars (\$33,329.00) was expended on the rehabilitation project, and, therefore, the Mortgagors and the City wish to amend and restate the Note and the Mortgage to correct the amount of the funds secured by the Note.


