#### (B) Amount of Semimonthly Payments

My Semimonthly payment will be in the amount of U.S. \$ 120.09.

#### (C) Manner of Payment

My Semimonthly payments will be made by an automatic deduction from an account I will maintain with the Note Holder, or with a different entity specified by the Note Holder. I will keep sufficient funds in the account to pay the full amount of each Semimonthly payment on the date it is due.

I understand that the Note Holder, or an entity acting for the Note Holder, may deduct the amount of my Semimonthly payment from the account to pay the Note Holder for each Semimonthly payment on the date it is due until I have paid all amounts owed under this Note.

#### 2. TERM

#### (C) Calculation of Changes

Before each Change Date, the Note Holder will calculate my new interest rate by adding Two Percentage Point (2%) to the Current Index. The Note Holder will then round the result of this addition to the nearest one-eighth of one percentage point (0.121%). Subject to the limits stated in Section 4(D) below, this rounded amount will be my new interest rate until the next Change Late.

The Note Holder will then determine the amount of the Semimonthly payment that would be sufficient to repay the unpaid principal that I am expected to owe in full on the maturity date at my new interest rate in substantially equal payments. #### 4. FUTURE ADVANCES

This Mortgage also secures the payment of and includes all future or further advances as shall be made at all times, regardless of whether Loan proceeds have been disbursed, by the Mortgagor herein or its successors or assigns, to and for the benefit of the Mortgagor, its heirs, personal representatives, or assigns, to the same extent as if such future advances were made on the dage of the execution of this Mortgage.
