- 14. Uniform Mortgage; Governing Laws; Severability. This form of mortgage combines uniform covenants for ational use and non-uniform covenants with limited variations by jurisdiction to constitute a uniform security strument covering real property. This Mortgage shall be governed by the law of the jurisdiction in which the roperty is located. In the event that any provision or clause of this Mortgage or the Note conflicts with applicable w, such conflict shall not affect other provisions of this Mortgage or the Note which can be given effect without the onflicting provision, and to this end the provisions of the Mortgage and the Note are declared to be severable.
- 15. Borrower's Copy. Borrower shall be furnished a conformed copy of the Note and of this Mortgage at the time execution or after recordation hereof.
- 16. Transfer of the Property: Assumption.
