THIS MORTGAGE ("Mortgage") is made this FEBRUARY 6, 1998. between Mortgagor, COLLEEN C KENNEDY, UNMARRIED ("Borrower"). and the Mortgagee, Citibank, Federal Savings Bank, a corporation organized and existing under the laws of the United States, whose address is 500 West Madison Street, Chicago, Illinois 60661 ("Lender").

TOOETHER with all improvements now or hereafter erected co the property, and all easements, rights, appurtenances and rents all of which shall be deemed to be and remain a part of the property covered by this mortgage; and all of the foregoing, together with said property (or the leasehold estate if this Mortgage is on a leasehold are hereinafter referred to as the "Property."

3. Prior Mortgages and Deeds of Trust; Charges; Liens. Borrower shall perform all of Borrower's obligations under any mortgage, deed of trust or other security agreement with a lien which has priority over this Mortgage, including Borrower's covenants to make payments when due. Borrower shall pay or cause to be paid all taxes, assessments and other charges, fines and impositions attributable to the Property which may attain a priority over this Mortgage, and leasehold payments or ground rents, if any.

5. Preservation and Maintenage of Property; Leaseholds; Condominiums; Planned Unit Developments. Borrower shall keep the Property in good repair and shall not commit waste or permit impairment or deterioration of the Property and shall comply with the provisions of any lease if this Micrigage is on a leasehold. 10. Successor and Assigns Bound; Joint and Several Liability; Co-signers.
