ASSIGNMENT OF RENTS AND LESSOR'S INTEREST IN LEASES

(b) Observance and performance by Assignor of the covenants, terms, conditions and agreements contained in this Assignment, the Note, the Security Agreement and Assignment of Beneficial Interest of even date herewith made to Assignee, the Mortgage (the "Mortgage") of even date herewith made by Trustee to Assignee and creating a mortgage lien on the Trustee's fee simple interest in the Premises, the Environmental Indemnity Agreement of even date herewith made by Makers, WARREN MCELWAIN and RUSSELL MCELWAIN (collectively, "Guarantor"), the Continuing Guarantee of even date herewith made by Guarantor, the Security Agreement of even date herewith made by Assignor to Assignee, the Construction Loan Agreement of even date herewith made by Assignor to Assignee and such other documents executed in connection with the Note (collectively, the "Loan Documents").

- 1. Representations of Assignor. Trustee represents and warrants to Assignee that:

 - (b) Assignor has not heretofore made any other assignment of its entire or any part of its interest in and to any or all of the Leases, or any or all of the rents, issues, income or profits assigned hereunder or entered into any agreement to subordinate any of the Leases, or Assignor's right to receive any of the rents, issues, income or profits assigned hereunder; and

- 2. Covenants of Assignor. Assignor covenants and agrees that so long as this Assignment shall be in effect:

- (c) Assignor shall not collect any of the rents, issues, income or profits assigned hereunder more than thirty (30) days in advance of the time when the same shall become due, except for security or similar deposits;
- (d) Assignor shall not make any other assignment of its entire or any part of its interest in or to any or all of the Leases, or any or all rents, issues, income or profits assigned hereunder without the prior written consent of Assignee;
- Assignor shall not alter, modify or change the terms and provisions of any Lease or less favorable terms than the existing lease or give any consent (including, but not limited to, any consent to any assignment of, or subletting under, any Lease) or approval, required or permitted by such terms and provisions, or cancel or terminate any Lease without the prior written consent of Assignee;
- (f) Assignor shall not accept a surrender of any Lease, or convey or transfer, or suffer or permit a conveyance or transfer of, the Premises demised under any Lease or any interest in any Lease so as to effect, directly or indirectly, proximately or remotely, a merger of the estates and rights of, or a termination or diminution of the obligations of, any tenant thereunder,
- (g) Assignor shall not alter, modify or change the terms of any guaranty of any Lease, or cancel or terminate any such guaranty of do or suffer to be done anything which would terminate any such guaranty as a matter of law, without the prior written consent of Assignee;
- (h) Assignor shall not waive or excuse the obligation to pay tent under any Lease, except for the free rent given to existing tenants of the Premises,
- (i) Assignor shall enforce the Leases and all rights and remedies of the lessor thereunder in case of default thereunder by any tenant;

- 4. Events of Default. The occurrence of any one or more of the following shall constitute an "Event of Default" for purposes of this Assignment:
 - (a) Failure by Trustee to pay any installment of the principal sum of the Note and/or any interest thereon when due under the Note;
 - (b) Breach of any material representation, warranty, covenant or agreement made by Assignor in this Assignment,
 - (c) Any misrepresentation made by Assignor or Guarantor in any of the Loan Documents; and
 - (d) Any other event of default under the Netz or any of the Loan Documents, subject to any applicable cure period contained therein.
- Rights and Remedies Upon Default. At any time upon or following the occurrence of any one or more Events of Default, Assignee may, at its option and without any obligation to do so, without in any way waiving such Event or Events of Default, without notice to or demand on Assignor, without regard to the adequacy of the security for the obligations secured increby, without releasing Assignor from any obligation hereunder, and with or without bringing any action or proceeding:
 - (a) Declare a default under the Guarantee and enforce all rights and remedies available to Assignor under the Guarantee and Loan Documents secured thereby;
 - (b) Enter upon and take possession of the Premises, either in person or by an agent or by a receiver appointed by a court, and have, hold, manage, lease and operate the same on such terms and for such period of time as Assignee may deem necessary or proper, with full power to make from time to time all alterations, renovations,
