8. The heirs to the estate of HATTIE BEATRICE ROBINSON are as follows:

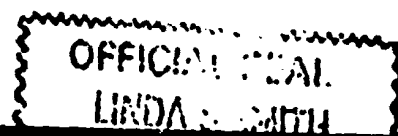
