- 8. Fees. Londer may collect fees and charges authorized by the Secretary.
- 9. Grounds for Acceleration of Debt.
 - (a) Default. Lender may, except as limited by regulations issued by the Secretary, in the case of payment defaults, require immediate payment in full of all sums secured by this Security instrument
 - (i) Borrower defaults by falling to pay in full any monthly payment required by this Security Insument prior to or on the due date of the next monthly payment, or

NON-UNIFORM COVENANTS. Borrower and Lender further covenant and agree as follows:
