FIRST; I give, devise and bequeath to my wife, Genowefa Nacyk all my right, title and interest in the following real estate.

The South 13 feet and 6 inches of Lot 26 and the North 21 feet of Lot 27 in Block 7 in Pierce's Addition to Holstein of the North half of the South West quarter of Sect 31, Township 40 North, Range 14, East of the Third Principal Meridian in Cook County, Illinois. 1916 N. Hoyne Ave.

If my wife, Genowefa Nacyk does not survive me I give, devise and bequeath all my right, title and interest in the foregoing described real estate unto my son, Casimir Nacyk, in fee simple, absolutely and forever. -

SECOND; I give and bequeath to my wife, Genowefa Nacyk all my personal estate whatsoever and wheresoever it may be. If my wife does not survive me I give and bequeath all my personal estate whatsoever and wheresoever it may be to my son, Casimir Nacyk.

THIRD; I nominate and appoint my wife, Genowefa Nacyk to be my Executor of this my Last Will and Testament, without bond or surety. Or if she fails or ceases to act as Executor then and in that event I nominate and appoint My Son Casimir Nacyk to be my Executor of this my last will and testament, without bond or surety.
