Specifically, and without limitation of the foregoing, if this Mortgage is given with respect to a leashold estate held by Borrower, and Borrower subsequently acquires a fee interest in the real property, the line of this Mortgage shall attached to and include the fee interest acquired by Sorrower.

Borrower, for itself and all who may claim through or under it, waives any and all right to have the property and estates comprising the Property marshalled upon any foreclosure of the lien hereof and agrees that any court having jurisdiction to foreclose such lien may order the Property sold as an entirety. Borrower hereby waives any and all rights of redemption from sale under any order or decree of foreclosure, pursuant to rights herein granted, on behalf of the Mortgagor, the trust estate, and all persons beneficially interested therein, and each and every person acquiring any interest in or title to the Property described herein subsequent to the date of this Mortgage, and on behalf of all other persons to the excess permitted by illinois law.
- 25. EXPENSE OF LITICATION. In any suit to foreclose the lien of this Mortgage or enforce any other remedy of the Lender under this Mortgage, the Agreement, or the Note there shall be allowed and included, as additional indebtedness in the judgement or decree, an expenditures and expenses which may be paid or incurred by or on behalf of Borrower for attorneys' fees, appraiser' fees, oxidays for documentary and expent evidence, stenographers' charges, publication costs, survey costs, and costs (which may be estimated as to items to be expended after entry of the decree) of procuring all abstracts of title, title searches and examinations, title insurance policies. Torrens certificates, and similar data and assurances with respect to title as Lender may deem reasonably necessary either to prosecute such suit or to evidence to bidders at any sale which may be had pursuant to such decree the true condition of title to or value of the Property. All expenditures and expenses of the nature in this paragraph mentioned, and such expenses and fees as may be incurred in the protection of said Property and the maintenance of the lien of this Mortgage, including the grees of any attorney employed by Lender in any litigation or proceeding or threatened suit or proceeding, shall be immediately due and payable by Borrower, with interest thereon at the defeat interest rate.

All the terms and conditions of this Mortgage and the other Credit Documents shall be binding upon and intent to the benefit of the heirs, successors and assigns of Borrower.
- 27. TRUSTEE EXCULPATION. If this Mortgage is executed by a Trust, Trustee executes this Mortgage as Trustee as aforesald, the exercise of the power and authority converred upon and vasced in it as such trustee, and it is expressly understood and agreed by the mortgagee herein and by every person low or hereafter claiming any right or security under that nothing contained herein or in the Note secured by this Mortgage and be construed as creating any liability on the Trustee personally to pay said Note or any interest that may accrue thereon, or any indebtedness accruing hereunder or to perform any covenants either express or implied herein contained, all such liability, if any, being expressly waived, and that any recovery this Mortgage and the Note secured hereby shall be solely against and out of the Property hereby conveyed by enforcement of the provisions hereof and of said Note, but this waiver shall in no way affect the personal liability of any co-maker, co-signed endorser or guarantor of said Note.
