THIS INDENTURE made the <u>1st</u> day of <u>January</u>, <u>1998</u>, by and between <u>PINNACLE BANK</u>. - 2. The maturity on the Note and Mortgage is extended from <u>01/01/98</u> to <u>01/01/99</u>.
- 3. The interest charged on the Note is R*+2% per annum. In consideration of the extension granted hereunder, Owner agrees to pay interest on the remaining indebtedness as follows:
 - a. \$69.909.12 at the rate of R*+2% per annum on the basis of a year consisting of 360 days;

* The designation of said rate includes a letter "R" or the terr. "Reference Rate", which at any time, from time to time, shall he at the rate of interest then most recently announced by the pank as its Reference Rate, and each change in the interest rate hereon shall take effect on the effective date of the change in the Reference Rate. The bank shall not be obligated to give notice of any change in the Reference Rate. The interest shall be computed on the basis of a year consisting of 150 days and shall be paid for the actual number of days elapsed, unless otherwise specified herein.

b. and the entire principal cum and interest from 01/01/98 shall be payable as follows:

Monthly interest only payments baginning on the <u>1st</u> day of <u>February</u>, <u>1998</u>, and the <u>1st</u> day of each month thereafter for the next <u>ten (10)</u> consecutive months and a final payment of the remaining principal and interest balance due and payable on <u>January 1</u>, 1999.

Interest after maturity (whether by reason of acceleration or otherwise) shall be paid on the unpaid principal balance at the rate of R*+2 per annum.

BORROWER SHALL PAY TO THE NOTE HOLDER A LATE CHARGE CF (5%) FIVE PERCENT OF ANY MONTHLY INSTALLMENT NOT RECEIVED BY THE NOTE HOLDER WITHIN 15 DAYS AFTER THE INSTALLMENT IS DUE.

The Owner agrees to perform all the covenants of the grantor or grantors in said Mortgage or Trust Deed, or any other Security Document. The provisions of this indenture shall inure to the benefit of any holder of said Note and shall bind the heirs, personal representatives and assigns of the Owner. The Owner, to the extent permitted by law, hereby waives and releases all rights and benefits under and by virtue of the Homestead Exemption Laws of the State of Illinois with respect to said real estate.
