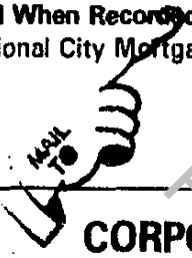

LEGAL DESCRIPTION

That part of Lot 11 in Wellington Court, Being a subdivision of part of the West 1/2 of the Northwest 1/4 of Section 33, Township 41 North, Range 10, East of the Third Principal Meridian, according to the plat thereof recorded December 29, 1988 as document no. 88598270 described as follows: Commencing at the Northeast corner of said Lot 11; thence South 53 degrees, 20 minutes, 00 seconds west along the Easterly line of said Lot 11 a distance of 170 feet to the most Southerly corner of said Lot 11; thence North 36 degrees 40 minutes, 00 seconds West along the Westerly line of said Lot 11, a distance of 16.43 feet for a place of beginning; thence continuing North 36 degrees, 40 minutes, 00 seconds West along the Westerly line of said Lot 11 a distance of 22.17 feet; thence North 13 degrees, 24 minutes, 46 seconds East 151.77 feet to a point on a curve, being the Northerly line of said Lot 11; thence Easterly along the arc of said curve, being the Northerly line of Lot 11, being concave to the South having a radius of 170 feet, having a chord bearing of South 86 degrees, 21 minutes, 49 seconds East for a distance of 17.05 feet; thence South 13 degrees, 24 minutes, 46 seconds West 167.18 feet to the place of beginning, in Cook County, Illinois.
