The base amount of the contract was Seventy-nine Thousand Five Hundred and 00/100 Dollars (\$79.500.00) and a total amount of extras in the amount of Nine Thousand Two Hundred Eighty-one and 00/100 Dollars (59,281.00) were authorized by the contractor, making the total amount due Eighty-eight Thousand Seven Hundred Fighty-one and 00/100 Dollars (\$88,781.00).
- That said contractor is entitled to condits on account thereof for payments made in the amount of and 001/00 Dallag (\$69.041.00) leaving due, unnaid and owing to the claimant. , for other
