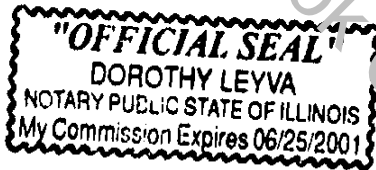

PARCEL 1:

THE EXCLUSIVE RIGHT TO USE PARKING SPACE NUMBER P-7W AND STORAGE SPACE NUMBER S-7W, LIMITED COMMON ELEMENTS, AS DELINEATED ON THE SURVEY ATTACHED TO THE DECLARATION AFORESAID RECORDED AS DOCUMENT 97904899.

GRANTOR ALSO HEREBY GRANTS TO THE GRANTEE, ITS SUCCESSORS AND ASSIGNS, AS RIGHTS AND EASEMENTS APPURTENANT TO THE ABOVE DESCRIBED REAL ESTATE, THE RIGHTS AND EASEMENTS FOR THE BENEFIT OF SAID PROPERTY SET FORTH IN THE DECLARATION OF CONDOMINIUM; AND GRANTOR RESERVES TO ITSELF, ITS SUCCESSORS AND ASSIGNS, THE RIGHTS AND EASEMENTS SET FORTH IN SAID DECLARATION FOR THE BENEFIT OF THE REMAINING PROPERTY DESCRIBED THEREIN.

THIS DEED IS SUBJECT TO ALL RIGHTS, EASEMENTS, COVENANTS, CONDITIONS, RESTRICTIONS AND RESERVATIONS CONTAINED IN SAID DECLARATION THE SAME AS THOUGH THE PROVISIONS OF SAID DECLARATION WERE RECITED AND STIPULATED AT LENGTH HEREIN.

THIS DEED IS FURTHER SUBJECT TO: (a) general real estate taxes not due and payable at the time of Closing; (b) applicable zoning, building laws and ordinances, which do not impair or adversely affect the use of the Unit as a condominium residence, provided the same are not violated; (c) the limitations and conditions imposed by the Acc; (d) the limitations and conditions imposed by the Municipal Code of Chicago provided the same are not violated; (e) the Condominium Documents including all amendments and exhibits thereto; (f) covenants, conditions, declarations, restrictions and building lines of record, which do not impair or adversely affect the use of the Unit as a condominium residence, which are reasonably acceptable to Purchaser; (g) acts done or suffered by Purchaser or anyone claiming by, through or under Purchaser; (h) encroachments, if any, as shown on the Plat of Survey to be attached as Exhibit "D" to the Declaration provided the same are insured over by the title company; (i) public utility easements, which do not underlie the Unit or adversely affect the value or existing use of the Unit, provided they do not underlie the building; (j) installments due after Closing for assessments levied pursuant to the Declaration; (k) private easements as provided for in the Condominium Documents; and (l) matters over which the title company has agreed to insure.
