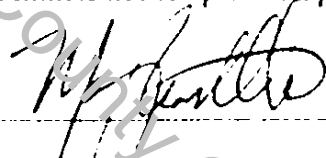
NOTICE OF LIEN

KNOW ALL MEN BY THESE PRESENTS, that George Street Terrace Lofts Condominium Association, an Illinois not-for-profit corporation, has and claims a lien pursuant to 765 ILCS 605.9, against Cole Taylor Bank as Trustee u.t.a dated January 19, 1995 and known as Trust No. 956182, 1318 West George Street Joint Venture and Needles Enterprises, upon the property described on the attached legal description and commonly known as 1318 West George Street, Unit 3-B, Chicago, Illinois

The property is subject to a Declaration establishing a plan for condominium ownership of the premises commonly described as George Street Terrace Lofts Condominium Association, recorded with the Recorder of Deeds of Cook County, Illinois recorded as Document Number 96793523. The Declaration and Section 9(g) of the Illinois

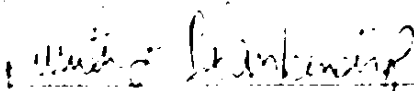
Condominium Property Act provide for a creation of a lien for unpaid common expenses or the amount of any unpaid fine or charges imposed pursuant to the Declaration, together with interest, late charges, costs, and reasonable attorneys' fees necessary for collection. The balance due to the Association for said amounts consisting of assessments collected by Developer, 1318 West George Street Joint Venture and Neidles Enterprises, at closing of units but not delivered to the Association pursuant to Article XVI, Section 11 of the Declaration, and unpaid and owing pursuant to the aforesaid Declaration and law, after allowing all credits, is the sum of \$2,900.00 through March 26, 1998. Said assessments, together with interest, late charges, costs and reasonable attorneys' fees constitute a lien on the aforesaid real estate

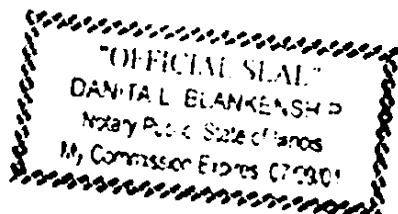
