This is the First Amendment to the Declaration of Condominium for the Villas of Sout i Holland, which is made on or as of the first day of March, 1998, pursuant to the provisions of the Illinois Condominium Property Act (Ill. Comp. Stat. 765, 605/1 et seq. (1996)). This document amends the Declaration of Condominium for the Villas of South Holland dated October 24, 1997, and recorded with the Recorder of Cook County. Illinois as Document No. 97828835, as amended from time to time (said Declaration and any amendments thereto are hereinafter referred to as "Declaration").

WITNESSETH

WHEREAS, the real estate described on Exhibit "A" of the Declaration, located in the County of Cook and State of Illinois ("submitted parcel") is being submitted to the Condominium Property Act of the State of Illinois ("Act") pursuant to the Declaration; and

WHEREAS, pursuant to the Act (as amended) in Article XVII of the Declaration, the Declarant reserves the right from time to time to add portions of the development area to the property and submit such portions to the Act and hereby add to the plan of Condominium. Ownership created by the Declaration; and

WHEREAS, the Declarant, pursuant to Article XVII of the Declaration, desires to add the real estate described on Exhibit "A" attached hereto ("legal description for property being submitted") to the property and add to the plan of Condominium Ownership, and submit the additional Parcel to the Act; and

WHEREAS, the additional Parcel is a portion of the legal description of the Parcel in the Declaration as described in Exhibit "E" therein ("additional property"); and

WHEREAS, the Declarant desires to arrend the Declaration as it relates to the Plat of Survey (Exhibit "B" hereto) and to the percentage of ownership and trust in the common elements for condominium units (Exhibit "C" thereto); and

WHEREAS, under Article XVII of the Declaration the Declarant has a power coupled with an interest as granted to the Declarant acting by and through its duly authorized officers as attorney-in-fact to shift the percentage of ownership in the common elements appurtenant to each unit to the percentages set forth in the Amendment to Declaration; and

NOW, THEREFORE, The Villas of South Holland, L.L.C., as owner in fee simple of the additional farcel, for the purposes above set forth, hereby declare the Declaration to be amended as follows:

- 1. The additional Parcel is hereby annexed to the submitted Parcel and together with all improvements and structures now or hereinafter erected, constructed or contained thereon, or therein, is submitted to the Act as part of the Condominium in accordace with and shall be deemed to be governed in all respects by the terms and provisions of the Declaration.
- 2. Exhibit "A" of the Declaration (the legal description of the Condominium Property) is hereby amended by deleting said Exhibit A and substituting therefore Exhibit A attached hereto.
- 3. Exhibit "B" of the Declaration (the Placo! Survey) is hereby amended by deleting said Exhibit B and substituting therefore Exhibit 3 attached hereto.
- 4. Exhibit "C" of the Declaration is hereby amended by deleting said Exhibit C and substituting therefore Exhibit C attached hereto. The percentage of ownership in the common elements appurtenant to each Unit is hereby shifted to the percentages set forth in Exhibit C attached hereto.
- 5. Exhibit "E" of the Declaration (the legal description of the Addinoral Property) is hereby amended by deleting said Exhibit E and substituting therefore Exhibit E attached hereto.
- 6. The additional Common Elements annexed by this instrument are hereby granted and conveyed to the grantees of all Units in the Condominium, including the grantees of Units heretofore conveyed, as all set forth in the Declaration.
