Article 4

The purposes for which the corporation is organized are:

- To engage in the administration and operation of property owned by an (a) Association, as permitted under Section 4 of the General Non-For-Profit Corporation Act and Section 18.1 of the Illinois Condominium Property Act, (the "Act"). The Corporation will administer and operate certain property located in the development known as the New Merrill Square Condominium.
- To a cuire and own real and personal property and any interests or rights therein (b) or appartingnt thereto as may be incidental to the purposes of the Corporation.
- To act or, behalf of its members collectively, as their governing body for civic (c) functions and other purposes, with respect to the preservation, care, maintenance, replacement, improvement, enhancement, operation and administration of both real and personal property for the promotion of the health, safety, and welfare, and the common use and enjoyment thereof by members of the Corporation, all on a not-for-profit basis and as more fully set forth in the Declaration for the New Merrill Square Condominium in Cook County, Illinois (the "Declaration"). ing Clerk;

Article 5

Other provisions:

Until the first meeting of the Owners after the Turnover Date, the Board of Directors shall consist of the three persons designated by the Declarant from time to time. From and after such meeting, the Board of Directors shall consist of the number of persons as provided for in the Declaration and By-Laws of the Corporation, but in no event fewer than three.
