This Meriorandum of Option ("Memorandum") is made as of March 31, 1998, by and between U-STOR-IT #17 (Fullerton) L.L.C., an Illinois limited liability company ("U-Stor-It"), and STORACE TRUST PROPERTIES, L.P., a Delaware limited partnership ("Storage Trust"), whereby the parties agree as follows:

- 1. Storage Trust hereby appoints U-Stor-It as Storage Trust's agent and attorney-in-fact with full power and authority to execute and record any and all documents deemed necessary by U-Stor-It to release, explain or terminate this Memorandum at such time as U-Stor-It in good faith determines that the Option Agreement has expired or otherwise been terminated with respect to the Land. Such appointment is coupled with an interest and is irrevocable.
