This Release does not release any covenants, warranties, indemnities or other obligations of Mortgagor under the Mortgage which by its terms expressly survives the release or termination of the Mortgage; provided, however, that this Release shall act as a full release and termination of all liens, claims and interests Mortgagee possesses under the Mortgage in and to the property, real or personal, as legally described on Exhibit A attached hereto and incorporated herein.
