MODIFICATION. Grantor and Lender hereby modify the Mortgage as follows:

Mortgage Note dated February 1, 1997 in the amount of \$250,000.00 ("Note 1") executed by Grantor. Grantor has requested and Lender has agreed to a) extend the maturity date of the Note to February 28, 2003; b) modify the interest rate of the Note to 8.00, fixed; and c) to amortize the current principal balance of the Note over 240 months:

Promissory Note dated June 25, 1997 in the amount of \$50,000.00 ("Note 2") executed by Grantor: Grantor has requested and Lender has agreed to a) extend the maturity date of the Note to February 28, 1999; b) provide additional financing to Grantor in an additional amount of \$50,000.00 as evidenced by that certain Promissory Note dated February 28, 1998 in the amount of \$100,000.00 ("Note 2") increasing the total amount of the indebtedness secured by the Mortgage to \$350,000.00. Except as modified hereby and the Notes all other terms and conditions and all other Loan Documents remain in full force and effect according to their terms. their terms.

Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Mortgage as changed above nor obligate Lender to make any future modifications. It is the intention of Lender to retain as liable all parties to the Mortgage and all parties, makers and endorsers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.
