TOGETHER WITH all the improvements now or hereafter erected on the property, and all easements, appurtenances, and fixtures now or hereafter a part of the property. All replacements and additions shall also be covered by this Security Instrument. All of the foregoing is referred to in this Security Instrument as the "Property."

BORROWER COVENANTS that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property and that the Property is unencumbered, except for encumbrances of record. Borrower warrants and will defend generally the title to the Property against all claims and demands, subject to any encumbrances of record.

5. Hazard or Property Insurance. Borrower shall keep the improvements now existing or hereafter erected on the Property insured against loss by fire, hazards included within the term "extended coverage" and any other hazards, including floods or flooding, for which Lender requires insurance. This insurance shall be maintained in the amounts and for the periods that Lender requires. ADDITIONAL COVENANTS. In addition to the covenants and agreements made in the Security Instrument, Borrowers and Lender further covenant and agree as follows:

- Except as provided below, paragraph 2 entitled "Funds for Taxes and Insurance as well as any reference to paragraph 2 will be ineffective during the term of the Note.
- Borrowers agrees to provide Lender with evidence of payment of applicable taxes, insurance premiums, and any other escrow items within a reasonable time after receipt of said evidence of payment as determined by Lender.
- At Lender's option, this Rider may become null and void and of no further effect if Borrower is in default under the terms of the Note or Security Instrument or if the Note in assumed.
- Any election by the Lender to forego any of its remedies under this Rider is not a waiver by Lender of its right to pursue such remedies.

Except as modified hereunder the Security Instrument is and shall remain in full force and effect.
