## NEMORANDUM OF MODIFICATION AGREEMENT

On the 20th day of March, 1998, FIRST OF AMERICA BANK-ILLINOIS, N.A., as successor by merger to LaGrange Federal Savings and Loan Association (hereinafter "Bank"), and THE CHICAGO TRUST COMPANY, not personally, but as Trustee under Land Trust Agreement dated July 1, 1988 and known as Trust No. 1091985, entered into a Modification Agreement of which this is a Memorandium.

By their agreement, the parties modified and extended the Mortgage in the original amount of \$5,000,000, on the real estate in Cook County, Illinois, dated December 29, 1992, and recorded December 29, 1992, as Document No. \$2-980477, on the real estate described on Exhibit A attached hereto.

In pertinent part, the parties agree to modify and extend the Note and Mortgage by providing that the final payment under the Note and Mortgage is extended to December 31, 1998. All the other terms, conditions and provisions of the Mortgage which secures the note are hereby ratified and confirmed in all respects except where modified or extended by the Modification Agreement between the parties.
