Parcel 1:

Lots 4 to 12, both inclusive, in Block 25 in the Bronx, a subdivision of part of the South East 1/4 of Section 16, Township 41 North, Range 13 East of the Third Principal Meridian, in Cook County, Illinois

Parcel 2:

Lots 1, 2 and 3 in Block 27 in the Bronx, a subdivision of part of the South East 1/4 of Section 16, Township 41 North, Range 13 East of the Third Principal Meridian, in Cook County, Illinois.

Parcel 3:

That part of Lots 4, 5 and 6 in the Assessor's Division of the Northeast Quarter of Section 21, Township 41 North, Range 13, East of the Third Principal Meridian, bounded and described as follows: Beginning at the point of intersection of the Northwestern line of Niles Center Road (formerly Gross Point Road) with the Northeastern line of the 100 foot right-of-way of the Chicago and North Western Transportation Company (formerly Chicago Northern Railway), as said right-of-way was recorded on January 23, 1904 as Document No. 3492596; thence Northwesternly along said Northeastern right-of-way line a distance of 1220 feet; thence Southwesterly perpendicularly to said right-of-way 41.50 feet; thence Southeasterly parallel with said right-of-way to a point on the Northwestern line of Niles Center Road; thence Northeasternly along said Northwesternly line to the herein designated point of beginning, all in Cook County, Illinois.
