MODIFICATION AND EXTENSION AGREEMENT

THIS AGREEMENT made as of this 22nd day of February, 1998, between MANUFACTURERS BANK, an Illinois Banking Corporation, hereinafter called First Party, and Wilson Zambonino and Ella Zambonino, his wife, the Obligors under the Note and/or the present owners of the subject property, hereinafter called Second Party,

#### WITNESSETH:

THAT, WHEREAS, First Party is the owner of that certain Note in the amount of THREE HUNDRED TWENTY EIGHT THOUSAND AND NO/100 (\$328,000.00) DOLLARS, secured by a Construction Mortgage dated August 22, 1997 and recorded in the Cook County Recorder's Office on August 25, 1997 as Document No. 97621595, encumbering the real estate described as follows:

AND, WHEREAS, the parties hereto wish to modify the terms of said Note by extending the maturity date thereof to August 22, 1998 and by increasing the indebtedness due thereunder by \$120,000.00.

NOW THEREFORE, in consideration of ONE DOLLAR, the covenants contained herein, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, it is hereby agreed as follows:

- 1. As of the date hereof, the outstanding principal balance due under the Note is \$327,999.80.
- 2. The outstanding principal balance due under the Note shall be increased by \$120,000.00 to become part of the undisbursed funds for the construction loan, thereby increasing the principal balance to \$447,999.80.
- 3. The maturity date of the Note and Mortgage hereinbefore described shall be extended from February 22,1998 to August 22, 1998.
- 4. In all other respects, the Note shall remain unchanged and in full icrce and effect, together with all documents, instruments or agreements that secure the Note (herein collectively referred to as "Loan Documents"). Specifically, it is understood and agreed that this instrument shall constitute and be an acknowledgment, confirmation and continuation of the rights, remedies, security interests and liens in favor of First Party existing under the Note and Loan Documents.
- 5. Second Party warrants and certifies that the indebtedness evidenced by the Note is a valid and subsisting debt of the Second Party that is in all respects free and clear of all defenses, setoffs and counterclaims, both in law and equity. Furthermore, this instrument confirms, ratified and assures a continuing lien against any collateral set forth in the Loan Documents, and nothing herein shall in any manner impair the priority of any such lien.
- 6. Notwithstanding the foregoing, Second Party expressly waives any defenses which it now has or may have or assert. Furthermore, in order to induce First Party to enter rate this Agreement, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, second Party for themselves and their heirs, personal representatives, successors and assigns do hereby release, remise and forever discharge First Party, its directors officers, employees, agents, successors and assigns of and from any and all setoffs, claims, counterclaims, demands, causes, causes of action, suits and/or judgments which it now has or may have against First Party and its directors, officers, employees, agents, successors and assigns including but not limited to matters arising out of the Note and/or any Loan Document, or arising out of any banking relationship

- 8. This instrument shall be construed and governed by and in accordance with the laws of the State of Illinois.
