I agree to indemnify the third party for any claims that arise against the third party because of reliance on this power of attorney.

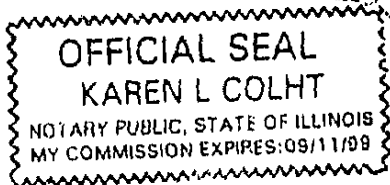
