## MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE IS DATED APRIL 23, 1593, BETWEEN Cosmopolitan Bank and Trust, not personally, but as Trustee under the provisions of a Trust Agreement dated November 3, 1995 and known as Trust No. 30377, whose address is 801 North Clark Street, Chicago, IL 60610 (referred to below as "Grantor"); ; and COSMOPOLITAN BANK AND TRUST (referred to below as "Lender"), whose address is 801 N. MORTGAGE. Grantor and Lender have entered into a mortgage dated Saptamber 25, 1997 (the "Mortgage") recorded in Cook County. State of Illinois as follows:
