### SUBORDINATION AGREEMENT

THIS SUBORDIA. (FON AGREEMENT, made in the City of Chicago, State of Illinois this 28th day of March, 1998 by The First National Bank of Chicago, a national banking organized and existing under and by virtue of the laws of the United States of America, and doing cusiness and having its principal office in the City of Chicago, County of Cook, and State of Illinois ("Bank).

#### WITNESSETH

WTIEREAS, the Earl is the owner of a mortgage dated October 12, 1995 and recorded October 18, 1995 among the land records in the Office of the Recorder of Dreas of Cook County, Illinois as Document Number 95-708584 made by Lee M. Karlin and Louis A. Karlin, His Wife ("Borrowers"), to secure an indebtedness of \$ 50,000.00 ("Mortgage"); and

WHEREAS, Borrowers are the owners of that certain parcel of real estate commonly known as 9211 Ida Lane, Merton Grove, IL 60053 and more specifically described as follows:

WHEREAS, CN I National Mortgage Company, its successors &/or assigns ("Mortgagze") has refused to make a loan to the Borrowers of \$ 92,000.00, except upon condition that the Mortgage be subordinate to said mortgage lien of Mortgagee.

NOW, THEREFORE, in consideration of the sum of Ten (\$10.00) Dollars in hand paid by each of the parties hereto to the other, and of other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged and in order to induce Mortgagee to make the loan to Borrowers, it is hereby mutually agreed, as follows:

- That the Bank covenants and consents that the lien of its Mortgage shall be subject and subordinate to the lien of Mortgagee's mortgage dated <u>APRII, 16, 1998</u> reflecting and securing the loan made by Mortgagee to Horrowers, in the amount of One Hundred Ninety Two Thousand and No/100 Dollars, and to all renewals, extensions or replacements of said mertgage; and
- II. That this Agreement shall be binding upon and shall mure to the benefit of Mortgagee, its successors and assigns.
