MODIFICATION AGREEMENT (Mortgage and Assignment of Rents and Leases)

WHEREAS, the parties hereto have agreed upon a modification of the terms and conditions of the Mortgage and Assignment as herein set forth; and

NOW THEREFORE, in consideration of the premises and the mutual promises and agreements hereinafter made by and between the parties hereto, the said parties do hereby mutually agree to modify the Mortgage and Assignment as follows:

- 5. All terms used herein and not otherwise defined shall have the respective meanings set forth in the Note, Mortgage and Assignment.

- 7. Mortgagor hereby agrees to execute and deliver, or cause to be executed and delivered, to Lender such additional documentation as Lender shall require in order to evidence or effectuate the transactions contemplated hereby or in order to update information and undertakings heretofore given to Lender by or on behalf of Mortgagor.
- 8. This Modification shall be governed by, and construed in accordance with, the internal laws of the State of Illinois.
- 9. This Modification shall inure to the benefit of Lender's successors and assigns, and shall be binding upon the successors and assigns of Mongagor.
